RELEASE & INDEMNITY AGREEMENT

-- READ CAREFULLY BEFORE SIGNING --

I, the undersigned, and if I am a person under 18 years of age, my parent(s) and I (hereafter "I") realize that **Yoga Fitness Classes** require **INTENSE PHYSICAL EXERTION AND HAS AN INHERENT RISK OF INJURY, OR POSSIBLE DEATH**. I understand that it is my responsibility to consult with a physician regarding my participation in this and any other Yoga Fitness Classes prior to participating in any class.

I agree to assume all risk of any property damage, personal injury or death that I might suffer which may be associated with, or result in any way from, my participation in any Yoga Fitness classes, activities, events or related activities associated with **Snowbasin Resort Company**. I hereby fully and forever release **Snowbasin Resort Company, its parent, subsidiary, brother, sister, closely related affiliated companies and all of their officers and directors, employees, agents and property owners (collectively hereafter "Snowbasin")**, from any and all claims, actions, demands, or liability for any injury or death occurring in or about the premises or in any way connected with my participation in any Yoga session, class, event, or related activity even if an accident, property damage, injury or death is the sole or partial fault of **Snowbasin**.

I have carefully read this Agreement. **I FULLY UNDERSTAND THAT THIS IS A RELEASE OF LIABILITY** which will legally **PREVENT** me or any other person from filing a suit or making any other legal claim in the event of my death or injury to me, **AND SIGN THIS ON MY OWN FREE WILL**. I further agree that my obligation to **INDEMNIFY AND HOLD SNOWBASIN HARMLESS** applies not only to a situation of causing injury, damage or death to myself, but also for any alleged fault caused by, or arising from, the negligence of **Snowbasin, its employees, agents, affiliated companies, or insurers, even if Snowbasin** is the sole or partial cause of any injury, property damage or death to any person, or entity. I also understand my obligation to **INDEMNIFY AND HOLD HARMLESS**, even if an accident, damage, injury or death is the sole or partial fault of **Snowbasin**. This agreement is binding upon my heirs, assigns, and legal representatives.

Participants under the age of 18 are required to have a parent read and counter-sign this agreement.

Persons under the age of 18 ("minor") are required to have an authorized parent or legal guardian (hereinafter "Parent") read and sign this Agreement. **To the fullest extent allowed by law, the Parent individually and on behalf of the minor has read, understood, and expressly agrees to all of the terms of this Agreement. The Parent agrees and acknowledges Parent's and minor's express assumption of risk, release of liability, indemnity and covenants not to sue Snowbasin, including for negligence.** The **Parent** agrees to make all decisions concerning the **minor's** participation, use of the area and involvement in Yoga Fitness classes, activities, events, or related activities. The **Parent** releases all of their rights or claims including wrongful death damages and agrees to indemnify **Snowbasin** for any other **Parent's** claims. The **Parent** agrees to pay all medical bills incurred by the **minor** and waives all rights of subrogation against **Snowbasin**.
